## Wowo's Club Terms of Service

## 1. ACCEPTANCE OF TERMS

Welcome to Wowo's Club. Wowo's Club provides its service to you, subject to the following Terms of Service ("TOS"), which may be updated by us from time to time without notice to you. You can review the most current version of the TOS at any time at:

www.wowosclub.org In addition, when using particular Wowo's Club services, you and Wowo's Club shall be subject to any posted guidelines or rules applicable to such services which may be posted from time to time. All such guidelines or rules (including but not limited to our Spam Policy) are hereby incorporated by reference into the TOS. Wowo's Club may also offer other services that are governed by different Terms of Service.

### 2. DESCRIPTION OF SERVICE

Wowo's Club currently provides users with access to a rich collection of resources, including, various communications tools, forums, shopping services, personalized content and branded programming through its network of properties (the "Service"). You also understand and agree that the Service may include advertisements and that these advertisements are necessary for Wowo's Club to provide the Service. law to the contrary, any claim or cause of action arising out of or related to use of the Service or the TOS must be filed within one (1) year after such claim or cause of action arose or be forever barred. The section titles in the TOS are for convenience only and have no legal or contractual effect.
